1. Members only may use the ranges; I will show my membership card at the range when asked. Non-members are not permitted to use the facilities.
2. I will use paper targets ONLY. Cans, bottles, plastic jugs, etc. are not permitted.
3. All my targets will be removed when finished shooting. This is my range and I will help keep it clean.
4. All my firearms will be unloaded when entering & exiting the range. Firearms will remain unloaded in racks with the action open until preparing to aim.
5. I will closely supervise youngsters under the age of 18 when shooting.
6. Each member agrees to indemnify, hold harmless and defend Transfer Sportsmen's Club, its agents, volunteers, and employees, and each of them against, and hold it and them harmless from, any and all lawsuits, claims, demands, liabilities, losses and expenses, including court costs and attorney's fees, for or on account of any injury to any person, or any death at any time resulting from such injury, or any damage to property, which may arise or which may be alleged to have arisen out of or in connection with the property or events of Transfer Sportsmen's Club.
